Press release from SCDC below:

"Communities urged to have their say on Cambridge-Oxford rail link Councillors are urging communities to have their say on proposed routes a new railway line between Cambridge and Oxford may take across South Cambridgeshire.

Leading Councillors have said the new railway link plays an important part in maintaining a thriving economy in South Cambridgeshire and will genuinely open up employment opportunities as Oxford can be reached in just 70 minutes on the train.

Routes for consultation published today (Monday 28 January) by East West Rail include options that could include a new station near Cambourne or Bassingbourn. South Cambridgeshire District Council will be responding to the consultation after debating it at a Cabinet meeting on 6 March.

The Council wrote to the Government and promoters of the railway following a Council

meeting in September to call on them to give the environment full and through consideration when selecting the route.

Councillors supported a motion in September that said that the railway line "presents us with an unprecedented opportunity to make positive contributions to net biodiversity and natural capital gains".

At the time Councillors said that they fully support the railway line as it will be transformational to the regional economy, but want to see issues such as flood management, noise and air pollution and health taken into consideration from the start of the project, so they are fully considered when selecting the route.

They have also said that the route assessment must also be based on how it can support thousands of new jobs and homes already planned for the area in the Council's Local Plan.

Councillors are urging people to make sure they have their say during the consultation and recognise that the information published raises a lot of questions they will be asking the promoters on behalf of communities.

Cllr Aidan Van de Weyer, South Cambridgeshire District Council's Deputy Leader, said: "The new railway line is important to the area as we need genuine alternatives to the car to help people to get around for work and leisure. It also opens up a huge part of the country to our residents where no direct and fast public transport links have been available. The information published raises many questions for me, such as how the wide areas they have provided as potential routes will be narrowed down, what level crossings will be needed, will any roads need to be closed and where will stations be located?

"We have a huge opportunity to deliver a fantastic transport link whilst also making sure that the route delivers a positive environmental legacy too. We want South Cambridgeshire to be green to its core and will be making sure the importance of the highest environmental standards is made crystal clear.

"We will be making sure the views of our communities are heard by responding to the consultation, but I want to urge everyone locally to have their say."

5.2 <u>CamBed RailRoad proposals for Cambridge to Bedford Rail link</u>

"You may be aware the East West Rail Co has started a non-statutory public consultation seeking views on their five different Route Options (A to E) for the Bedford to Cambridge railway line. We are writing to you to highlight that some of those Route Options include your Parish within their hatched areas of search or lie very close to it, as we have shown on the two more detailed traced maps attached (with our Alternative). In our opinion none of the five Options are suitable. None of them demonstrate any real compatibility with the recommendations of the National Infrastructure Commission (as accepted by Government) which very clearly set down a principle that the trainline should share the East West Expressway (A428) 'transport spine', where it could connect both the current and the many already approved future centres of population.

CamBedRailRoad has promoted an alternative routing from Bedford South through new stations at St Neots South, Cambourne, Northstowe and Cambridge South, via Cambridge North and Cambridge Central, reinforced by our <u>Arguments for Northern Approach into Cambridge</u>. Our route provides transport for almost 54,000 more residents than EWR Co's Options B & E and over 100,000 more than Options A, C and D. It has been supported by residents, Parish Councils (including Cambourne), Town Councils (including St Neots) and many of our local MPS and Councillors.

Our further major concern is that the consultation makes no reference to the level of housing development that will come with any railroad. EWR Co considers that Bassingbourn could deliver up to 30,000 new homes (about 5 times the size of Royston) and Tempsford up to 50,000 (about 10 times the size of Sandy). Are you prepared for a new development of such a size in your vicinity?

We would ask you to please ensure that your residents are aware of this consultation and exercise their right to respond, by the deadline of 11 March 2019. We suggest how, at our <u>Guidance on completing EWR Co's Feedback Form</u>. We have a once in a lifetime opportunity to deliver major infrastructure in a sensible and coherent way combining road, rail and housing: the Options currently promoted by EWR Co fail to do that. There is a great deal more at <u>www.cambedrailroad.org</u> with further maps and links to a wide range of resources which we shall be supplementing shortly. We would of course be happy to come and explain our proposals to you."
